I certify that during the past calendar year I did not participate on behalf of the City of Fruitland in the decision making process on any matter which would, to my knowledge, have a direct financial impact, as distinguished from the public generally, on me, my spouse, a close relative or any business entity with which any are affiliated.

I further certify that neither I, my spouse, close relative or a business entity with which any are affiliated held, hold or acquired an interest of \$10,000.00 or of one percent (1%) or more in a business entity that has a contract with or is negotiating a contract with a gross value of \$3,000.00 or more with the City or is regulated by the City during the past calendar year; nor have I, my spouse or a close relative been employed by a business entity that has a contract with or is negotiating a contract with a gross value of \$3,000.00 or more with the City, or is regulated by a City agency, except as exempted by the Fruitland Ethics Commission pursuant to Section 6 of Ordinance Number 193, and, if such is the case, it is as follows:

I further certify that neither I, my spouse or close relative hold any outside employment relationships that would impair our impartiality or independence of judgment, or, in the case of a full-time City employee would regularly conflict with my full-time City employment so as to require me to recuse myself from performing my job on a frequent basis, as determined by the Fruitland Ethics Commission.

I further certify that neither I, my spouse or close relative have represented any party during the past calendar year, for a contingent fee, before any City body, and, if such is the case, it is as follows:

I further certify that I have not solicited nor accepted any gifts from any person or business entity that has a contract with the City or is regulated by their agency, except when these gifts would not present a conflict of interest or determined by the Fruitland Ethics Commission. The term "gift" is intended to include the transfer of anything of value without adequate and lawful consideration which has an intrinsic value of greater than twenty-five dollars and zero cents (\$25.00) or alternatively can be used up or consumed within one day and has an intrinsic value of greater than one hundred dollars and zero cents (\$100.00). The term "gift" does not apply to such transfers from family members or others to whom the recipient is a natural recipient of their bounty based on love and affection. If the case be otherwise, it is as follows:
